Sir/Madam.

In compliance to the letter dated 09.09.2024 of Medical Assessment and Rating Board (MARBH) referred above, an affidavit has been received from the Principal/Authority of Atal Bihari Vajpayee Homoeopathic Medical College, AI- Jalike (BK), Khadke, Tq-Newasa, Dist. Ahmednagar-414603

The College has applied permission for sanction for BHMS course with 60 seats for the Academic Year 2024-25 through online portal. MARBH examined the profile of the college so as to assess the compliance to minimum essential standards to be fulfilled as per the regulations enforce at the time of calling applications and other provisions of NCH Act 2020. On careful examination of the report following shortfalls have been observed:

1. Miscellaneous

Form 16 is not from Traces portal.

IPD and OPD case records should be maintained with demographic details of the patient such as Name, Age, Sex, Address, Phone number, etc. Diagnosis of the case shall be recorded as per ICD 11criteria. All follow-up attendance should be recorded on the case records. Case sheets shall be maintained with complete case history, analysis and evaluation and repertorisation as per Homoeopathic Principles and made available in the Medical Record Room for academic purposes of students and follow up of patients.

Therefore, considering the above shortfalls and facilities available, MARBH has decided to issue conditional permission to Atal Bihari Vajpayee Homoeopathic Medical College, AI- Jalike (BK), Khadke, Tq-Newasa Dist. Ahmednagar-414603 Maharashtra for continuing BHMS course with intake capacity 60 Seats for the Academic Year 2024-25.

All deficiencies noticed shall be rectified within a period of one month and the compliance report shall be submitted for verification.

It is further to mention that all admissions shall be made for NEET qualified candidates only. It is further informed that minimum 15% of undergraduate seats of the permitted intake capacity of 60 UG seats shall be treated as All India Quota. Counselling for seats under All India Quota shall be conducted by respective counselling authority of State/UT Govt. as designated by Central Government/NCH for A.Y2024-25 and counselling for the remaining 85% seats or as the case may be, shall be conducted by the concerned Counselling Authority of the State/UT.

The category wise list of the selected candidates must be informed to the Medical Assessment and Rating Board for Homoeopathy after the process of admission is completed. Any admissions carried out other than NEET qualified students will not be approved by the Medical Assessment and Rating Board.

Permission to college can be withdrawn or denied in the subsequent year, if college is found deficient in compliance to MSR 2013 anytime during the academic year.
